- (a) Languages:- Hindi Core, Hindi Elective, English Core, English Elective.
- (b) Elective Subjects: Physics, Chemistry, Biology, Mathematics, Accountancy, Business Studies, Economics, Informatics Prac., Computer Science, Physical Education.

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes:

1. "The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Senior School Certificate Examination and changes made therein from time to time."
2. The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes of the Board upto Classes X.
3. The school will follow the CCE scheme at Secondary level as per the guidelines of the Board issued from time to time.
4. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State Govt./UT Govt. from time to time.
5. It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools.
6. The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.
7. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
8. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
9. It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
10. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
11. The school will strictly adhere with all rules regarding safety of students including Fire fighting, Drinking water, Sanitation, Transportation, etc.

12. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-Primary to Class XII :-

- (d) School running on bigger campus of more than 02 acres, the number of students shall be restricted as per the actual facilities in the school which shall be proportionate to the optimum number mentioned at (a), (b) and (c) above.
- (e) Schools running on less than 01 acre campus shall restrict number of students as follows:-

13. School will provide physical facilities as per norms of the Board. The facilities reported at the time of last inspection are as given under:-

14. The school will apply for further Extension of Provisional Affiliation on the prescribed form together with the prescribed fee of **Rs. 25,000/-** and other essential documents in the preceding year before the expiry of the date of provisional affiliation failing which penalty @ Rs. 10,000/- per month or maximum upto Rs.50,000/- will be charged for late execution of application.
15. The school will open CBSE pattern classes XI w.e.f. 1.4.2014. Accordingly, 1st Batch of class XII of the school will be appearing at the CBSE Examination to be held in 2016.
16. Other conditions are as per Annexure 'A' enclosed.
17. Special conditions to be complied within three months:-
 - i) Every School should organize at least one week training programme for teachers every year in association with any teachers training institute recognized by the State or Central Govt. or by any agency identified by the Board.
 - ii) Every institute will provide adequate facilities for potable drinking water and clean healthy and hygienic toilets with washing facilities for boys and girls separately in proportion to the number of students.
 - iii) School is required to finish construction work immediately.
 - iv) School is required to purchase more equipment to carry out experiment in the laboratories.
 - v) Principal of the school should be Member Secretary of School Managing Committee.
 - vi) The School Managing Committee has not been constituted as per Affiliation Bye-laws, therefore, it may be reconstituted by including 02 representatives of teachers of the concerned school.
 - vii) The school is required to submit certificate from the Banker regarding disbursement of salary through Bank advice by single cheque.
 - viii) The school is required to submit complete staff statement as per Appendix I of Affiliation Bye-laws of Board.
 - ix) The number of students enrolled is more than 40 students in almost all sections. Therefore, enrolment should be restricted with optimum number of 40 students in each section.

- x) The school is required to appoint qualified and experienced PGTs before commencement of Senior Secondary Classes.
- xi) The school is required to pay prescribed pay scales along with DA and other admissible allowances to the staff at least at par with the State Govt. pay scales.
- xii) Audit Certificate from registered Auditor required in respect of School Accounts.
- xiii) The school is required to send Principal/teachers for CCE, In-service, refresher/ re-orientation programme to update their knowledge and teaching skills from time to time.

Other Conditions:

Conditions for which compliance to be submitted within three months from the date of issue of sanction letter:-

1. Running starting of Class IX/X & XI/XII without prior Provisional Affiliation upto Secondary level from the Board would be unauthorized and school shall be responsible for the consequences arising out of it
2. Non-submission of application for extension of provisional affiliation by 30th June of the year preceding to the year by which provisional affiliation granted, expires, would also attract violation of provisions of Affiliation Bye-laws.
3. School will not prepare any student/start any class for any other Board except CBSE from their CBSE Affiliated school building/premises.
4. The Board would not allow any transfer of property/sale of school by one society/ Management/ Trust to another Society/Management/Trust through agreement/sale deed and the school shall not be closed down in the same premises. In case such transaction is effected explicitly or implicitly the Board shall withdraw its affiliation with immediate effect.
5. Pay & Allowances to staff should be revised from time to time to bring it at par with that to State Government.
6. The service conditions be strictly followed as per State Education Act and Staff be given appointment/confirmation letters etc. accordingly.
